- Collects and analyzes data from criminal justice agencies for the purpose of identifying and researching policy and programmatic changes to enhance the efficiency and effectiveness of the criminal justice system both substantively and fiscally
- Presents report findings and conclusions to a wide variety of audiences including government administrators, elected officials and the public
- Facilitates communication with justice stakeholders and local communities to promote an understanding of the administration of criminal and juvenile

justice in Navajo County and the public safety issues and challenges facing the county
